### **Gardener Membership:**

**\$40 each** per household, per calendar year, payable in advance. This helps offset the cost of water and supplies to sustain the garden.

### **Garden Management:**

We are a cooperative community garden managed by each season's gardeners, under the supervision of Calvin Hospitality/Facility Director. Gardeners can expect to work at least 1-2 hours a week in the garden either individually or in small scheduled work parties during the active garden season.

### **Problems or Conflicts:**

### **Visibility and Interaction:**

One of our goals is to be a model for the neighborhood, encouraging organic gardening and sustainable living, so we encourage gardeners to engage in friendly interaction with curious neighbors and people walking by.

### **Organic Community Garden Policies**

1. **Security:** Calvin Church does not provide security for this visible and easily accessible location. Please be accountable for garden as a whole and your own tools. Garden tools will be available for use on scheduled work days.
2. **Awareness:** As a member of the garden, please help us monitor what is happening in garden and report any suspected theft or vandalism.
3. **Organic purity:** Use of any pesticides, herbicides or other chemical garden products is prohibited in this organic community garden.
4. **Volunteer:** As a member of the garden, each gardener is expected to volunteer during the season to help maintain the garden as a whole.
5. **Smoking:** Smoking is prohibited in the garden and within 25 feet of it.
6. **Alcohol:** Alcohol consumption is prohibited on the entire Calvin Church grounds.
7. **Dogs:** Dogs are not allowed in the garden or within 25 feet of it, unless it is a registered service animal.
8. **Minors:** Children and teens are encouraged to work in the garden but must be supervised by an adult at all times.

- 9. **Water:** Water is a precious and necessary resource for the garden. We do not want to waste it. There are 2 water faucets within the garden. (We might be moving to an automatic system.)  
 ALWAYS COMPLETELY TURN OFF THE WATER before leaving the garden.  
 PLEASE DO NOT leave water running unattended for any reason.  
 Most of the garden beds have an automatic drip system.
- 10. **Vehicles:** Vehicles may be parked in the Calvin parking lot. PLEASE, NO VEHICLES on the grounds around the garden without permission from Calvin Staff.
